What is the U.A.E. Pension Fund?

The U.A.E. Pension Fund is a merger of six mostly European entrepreneurs who have their place of business in the U.A.E. (United Arab Emirates). They have placed as a holding structure in the mostly known Emirate Dubai. The board of management is led by an Arabic sheik.

What does the U.A.E. Pension Fund offer?

The U.A.E. Pension Fund offers every person who will not have reached its 67th birthday till 31st December 2009 the opportunity to cede prematurely a pension insurance taken out by U.A.E. Pension Fund and in return receiving a compensation payment.

The program is terminated as suspected till 31st December 2009.

How does it work?

The U.A.E. Pension Fund takes out a private pension policy at your name.

What does distinguish the U.A.E. Pension Fund?

The concluded insurance sum of U.A.E. Pension Fund is amounted to a total of € 300,000.00. Through your premature assignment declaration you will get a compensation payment of € 80,000.00. Additionally you will get € 3,000.00 as a commission payment for each sponsored member finally to your sixth's downline level. The maximum amount of policies is limited to 70,000, so that in all a very fast expiry can occur.

Costs and duties for member?

To register as a member for U.A.E. Pension Fund the member has to pay € 51.00 for each policy. This contains every administrative and transactional costs. The only duty arising for the member is the truthfully information of required personal information. Through assignment declaration all rights and duties of the insurance policy will be transferred to the holding company of U.A.E. Pension Fund, so that no additional payments will be necessary.

Safety for member

€ 1.00 of the costs per policy will be used to pay a lawyer versed in international insurance law to assure legality.

If the lawyer's fee will not be fully used, (€ 50,000.00) the remaining amount will be donated to charity like, Stefanie Graf foundation "children for tomorrow" and/or SOS Kinderdorf

Compensation payment

The compensation payment of € 80,000.00 will be paid after the insurance policy was transferred to the U.A.E. Pension Program holding company. There are two models how to get paid:

- 1 Payment to your existing bank account
- 2 A bank account in Dubai will be opened in your name into which the money will be transferred. In addition you will get a debit card, which offers you to withdraw money from every worldwide ATM accepting debit cards

Important: All income from the U.A.E. Pension Fund is taxable.

Sponsoring / commission payments

Everyone sponsoring a new member will get a commission of € 3,000.00 for that member. This commission will be paid six levels deep, even if a member in your downline sponsors the member falling into the six levels.

As a bonus, the 20 top sponsors will be awarded with a journey for two weeks to the Emirates Palace in Abu Dhabi including € 10,000,00 pocket money.

There is no requirement to sponsor. Rather it is a possibility or opportunity. The compensation payment is independent of sponsoring so that the member who does not sponsor also will get the compensation payment.

What will happen when the minimum of 50.000 policies will be registered?

Once the minimum of 50.000 policies will be reached all members will receive a document by post together with a card (if the member chose this opportunity in the agreement).

How and when will the payment take place?

Once your documents will arrive in Dubai 2-4 more weeks will pass (already done, because the agreements are already sent to Dubai). During this time a bank account will be opened for you in Dubai (provided you have chosen this model in the agreement) and you will get a debit card to use worldwide.

If you should choose the transfer to your existing bank account, a bank account in Dubai will not be opened and you will not get a debit card. The transfer then will follow within 1-2 weeks as well
